Dear NYSAR Members,

NYSAR conducted a member-wide survey April 4 – 6. The purpose of the survey was to help inform the Board of Directors as it considers future guidance for the NYSAR Leadership Team and staff as they advocate on the membership’s behalf.

“We are thankful so many members took the time to participate in this survey. The data is consistent from across the state even though the occurrence of COVID-19 is more impactful in some parts of the state than others. We are one association and we will support each other and the safety of our communities,” said NYSAR President Jennifer Stevenson.

More than 48,500 members were sent the survey and our vendor, Spectrum Associates, obtained 11,354 completed surveys. This sample size provides a confidence range of +/- .8 at a 95% confidence level. We know that not everyone who wanted to complete the survey was able to and we are investigating how to improve the email data. From a statistical standpoint, we have a much, much larger sample than is needed to feel very confident in the study findings. The survey results are as follows.
